

Transportation Improvements Coming Around Pioneer Street and Interstate Junction

PROJECT	YEARS OF CONSTRUCTION
1 Widen Pioneer Street (4 lanes) from 56th Place to Royal Road	2024
2 Build the South 10/11th Street Corridor and I-5 overpass	2028
3 Widen Royle Road to minor arterial (3 lanes)	2024/25
4 Build Pioneer Canyon Drive as industrial/commercial collector	2024
5 Build N 51st Ave as industrial/commercial collector	2024/25
6 Build N 56th Ave as industrial/commercial collector	2024
7 Build N 51st Ave as minor arterial	2024
8 Build new east-west collector south of Pioneer (SR 501)	2024/25

The 2016 Update to the Ridgefield Comprehensive plan, developed with community input, outlines direction and policies to accommodate 8,708 new jobs, consistent with the City vision to develop a regional employment center, quality neighborhoods, and a complete community. The Junction subarea, centered around I-5 and Pioneer Street, plays an important role in attracting employers who provide high-quality jobs and employment opportunities for residents. Construction will begin soon on critical infrastructure improvements to increase the capacity of the area before new retail and services open.

A group of interconnected transportation infrastructure projects are planned in the area to accommodate the expected increase in traffic volume and provide access to new areas. Several of these projects will be completed by private developers, paying for the increased infrastructure needs their projects create. Other portions must be completed by the city. The project list and map above provide an overview of the work to be done. The City has an opportunity to design the area to be pedestrian and cyclist friendly, while addressing the need for increased vehicle traffic capacity. We Are Severe Weather Ready, Are You?

Public Works prepares for severe weather events by diligently following weather reports and readying equipment. In severe weather, crews begin clearing streets in the early hours to prepare main roadways for the morning commute. When appropriate, the City deploys the following methods to improve driving safety:

- Pretreat streets with magnesium chloride to lower the freezing temperature of water.
- Plow to within one-half inch of the pavement.
- Distribute sanding rock to help provide traction. When sanding rock is used, it is practice to sweep streets to remove rock after the event has passed.

WHAT YOU CAN DO TO PREPARE

- Get a snow shovel and broom. Clearing sidewalks is the responsibility of adjacent property owners.

Envision Ridgefield 2045 is a multi-year initiative to update the City's long range planning document, the Comprehensive Plan. As we work to update the plan, community members and the City will work together to develop a guide for Ridgefield's growth and development. There will be numerous ways to get involved throughout this process including community survey, stakeholder interviews, conversations and community events, and public open houses. Early outreach will focus on visioning, while later conversations will focus on specific topics included in the plan, such as land use, economic development, transportation, and parks. Budgeting for City Priorities & Measuring Our Success

Ridgefield City Council adopted the 2024 City Budget on December 7, 2023. The expense budget includes \$52.3 million in strategic capital investments such as widening Pioneer Street and constructing a roundabout at 50th Ave, construction of a 5-million-gallon water reservoir on the east side, and the Kennedy well field project to prepare for growth projected over the next 20 years. The implementation of a local tax increment financing plan near the Interstate 5 junction will provide the financial footing for the city to build infrastructure that will spur an estimated \$700 million dollars of private development. This commercial development will provide services requested by Ridgefield residents and sustainable property and retail sales tax growth. The operating budget of \$24.7 million will support continued high priority public services such as public safety, streets, water, parks and community events. The budget also includes six new full-time staff positions, two additional police officers and four public works maintenance workers.

As a planning and policy document, one fundamental purpose of the City's budget is to allocate resources that support the community's vision and priorities. City Council has adopted seven organizational goals to provide direction for staff and policy decisions. New services or initiatives are considered based on how they assist in meeting these organizational goals. The goals are:

- **Goal Number 1:** Plan and Manage the Growth of the City
- **Goal Number 2:** Revitalize Downtown as a Destination Location
- **Goal Number 3:** Create and Maintain Economic Stability for the City
- **Goal Number 4:** Assure the City's infrastructure is able to Meet Growing Community Needs
- **Goal Number 5:** Retain Culture and History of Ridgefield
- **Goal Number 6:** Maximize the City's Natural Resources and Attractions
- **Goal Number 7:** Actively Engage and Communicate with the Ridgefield Community



Staff have developed performance measures within these goals to provide a quantifiable way to recognize success and identify areas for improvement. Performance measures also offer transparency and allow the public to hold the City accountable for stated objectives. These metrics can be reviewed in the digital budget by scanning the code above.
