- ☐ 2. **SITE PLAN:** A site plan that contains a graphic scale and shows property lines and dimensions; building footprints and dimensions; roads, driveways, parking lots; existing signs to be removed; existing signs to be retained; and location and orientation of proposed sign(s).
- ☐ 3. **BUILDING ELEVATIONS:** Plans that show the building facade showing location, sign dimensions, method of attachment, type of illumination (if any), and advertising verbiage.
- ☐ 4. **FRONT AND SIDE ELEVATIONS:** Plans of front and side elevations for any free-standing signs that show support detail, sign dimensions, type of illumination (if any) and advertising verbiage.
- ☐ 5. **STRUCTURE CALCULATIONS**
- ☐ 6. **NARRATIVE:** A narrative that describes the proposed project and addresses criteria in RDC 18.710 relevant to sign type.
- ☐ **FEES:** Plan check fees must be paid prior to review via permit portal or check made payable to City of Ridgefield.
